# **Experience**

### **Appellate Victory**

Obtained a favorable summary judgment ruling in trial court for a client in a case that addressed a fundamental aspect of contract law – the doctrine of implied revocation. The main issue was whether a purported offer to settle a debt for a reduced sum was accepted before it was revoked. The case's rulings were appealed and reversed by the Court of Appeals. The Texas Supreme Court reversed and rendered judgment in our client's favor in January 2022..

### **Business Litigation**

Representing plaintiffs in a suit seeking more than \$150 MM for breach of contract, breach of trust, fraudulent transfer and promissory estoppel. U.S. District Court for the Southern District of Texas (Houston Division).

#### **Breach of Contract**
