TRUSTEE’S MOTION FOR EXPEDITED HEARING TO CONSIDER  
TRUSTEE’S MOTION TO COMPEL FINANCIAL DISCLOSURES OF CERTAIN  
WARRANT ISSUERS AND EXTENSION OF THE WARRANT PERIOD FOR 10  
YEARS FOR FAILURE TO COMPLY

TO THE HONORABLE SHAD M. ROBINSON, U.S. BANKRUPTCY JUDGE:

Randolph N. Osherow, not individually but in his capacity as the duly appointed chapter 7 trustee (in such capacity, the “Trustee”), for and on behalf of ASTRALABS, Inc. (the “Debtor”) under the above-captioned chapter 7 bankruptcy case (the “Bankruptcy Case”), hereby moves for an expedited hearing of his *Motion to Compel Financial Disclosures of Certain Warrant Issuers and Extension of the Warrant Period for 10 Years for Failure to Comply* [Docket No. 455] (the “Motion”)<sup>1</sup>, in support of which, the Trustee respectfully shows as follows:

1. The Trustee moves for an expedited hearing to consider the Motion, under which the Trustee requests entry of an order compelling all issuers of any and all Warrants listed as a Sale Asset to comply with this Court’s Order [Docket No. 423], provide the requested financial information pursuant to the Accelerator Warrant Section 2 within seven (7) days of entry of the Order Granting the Trustee’s Motion, and failure to comply with the financial reporting obligations will result in the automatic extension of the Warrant Period to 10 years, commencing from the initial date of the Warrant.

2. An expedited hearing is warranted because the disclosure of financial information is necessary to aid in the sale of the remaining<sup>2</sup> Warrants held by the Estate and listed as sale assets (collectively, the “Sale Assets”).

3. The bid deadline for the Sale is August 2, 2024.

4. Expedited consideration of this Motion is, accordingly, necessary in the best interests of the Estate, in order to accommodate the already pending Sale process. The Trustee’s receipt of the requested disclosures must be resolved in time to accommodate due diligence and bidding under the Court-ordered Sale Procedures. Absent such expedited consideration, the value of the Sale Assets, and the Trustee and the Estate’s corresponding interests, would be adversely impacted.

5. The Trustee was unable to reasonably submit this Motion with substantially greater notice due to the inability to analyze and determine compliance and noncompliance, and prepare the Motion, until the expiration of the June 3, 2024 objection deadline set forth in the Sale Procedures.

6. The Trustee requests that the Motion be heard at the earliest expedited setting as to which the Court is available and amenable. The Motion includes a seven (7) day cure period to ensure issuers have proper and sufficient notice to comply with any Order granting the Motion. Of course, as previously Ordered by the Court, all such issuers have, in fact, already had due notice of the Request for Disclosures, and an ample opportunity to comply (or object) under the Court-ordered Sale Procedures.

7. Accordingly, an expedited hearing is consistent with the foregoing authorities and warranted due to the upcoming Sale bid deadline.

<sup>2</sup> The Trustee has entered into numerous redemption offers that are pending Court approval. The number of Warrants to be sold excluding canceled Warrants and the pending redemptions offers is approximately 1278.

WHEREFORE, the Trustee respectfully requests that this Court grant this Motion for an expedited hearing to consider same as soon as the Court is available and amenable, and grant the Trustee such other and further relief as the Court deems appropriate.
